Words from the past: Early URMIA member Truman Pope

EDITOR'S NOTE: This note from Truman Pope was submitted to URMIA in the late 1980s or early 1990s.

When Uncle Sam cut me off from the good life of free room and board plus almost \$20 a week, my plans were to become a member of the Indiana State Police. As the next recruit class didn't begin for eight months, I took a "temporary" position at Ball State University that turned out to last over 40 years. The academic year 1982-83 was probably the last "good year" before the debacle of '84 struck sending the insurance markets into one of the most disastrous situations in recent times. Umbrella coverage was readily available then at the rate of \$800 per million. Today a million may cost \$14,000 if you can find it. But despite present hard times, 1982-83, like most other years, was one in which we all did our best to supply our respective universities with adequate protection at the least cost. We are unanimous in our opinion that ours is an enjoyable occupation with a certain amount of excitement that one does not find in other areas of our department. The uniqueness of some of the situations in which we find ourselves could be the subject of an interesting book.

The RIMS university industry meeting of 1982-83 was held in Los Angles, chaired by Marty Siegel and Mary Breighner, and fairly well attended by URMIA members. The high-light of the year was our annual conference which was hosted by the University of Alabama-Birmingham and its Risk Manager, John Walker. A first was established in that all name tags and programs were entirely computer produced. Many of us were most impressed by our first personal association with the London market in the person of Peter Wilson of H. S. Weaver Underwriters Agency. Our treasury had grown to around \$15,000 and we took steps to increase our own protection by purchase of a fidelity bond and additional liability coverages. We added ten new members, notably Vanderbilt and its Risk Manager, Bob Sinclair, to bring our total membership to one hundred fifty two of which the institutional split was about 40% private and 60% public. Work on the development of a History of URMIA was reported by Rena Schlager. Two committees were established, a Conference Committee and a Research and Development Committee. The Finance Committee was disbanded.

In a lighter sense, the group enjoyed a most memorable night at THE CLUB with its fabulous mountain top view of the lights and sights of Birmingham. The three actors known as "Wits Other End" had us rolling in the aisles and were just the dessert for a truly delicious meal. To add still further to these delights, John Walker arranged for a tour of the Alabama Space and Rocket Center and NASA. Most of have relived some of those educational moments in recent months of NASA publicity.

In closing, I wish to state that I hold my friends and colleagues in URMIA in great respect and affection. Of the various clubs and organizations with which I have been associated, I can truly say that my membership in URMIA has been one of the most pleasurable and rewarding relationships of my career. Of the awards that I have been presented during my many years of community service and university affiliation, the plaque in my office which is inscribed: PRESIDENT - University Risk Management Insurance Association - 1982-83, is by far the one which I most treasure. Thanks for the pleasure and memories of your past and continued friendship in a great organization.
